



**The Joint Venture Program (JVP) helps businesses reduce costs and increase profits with:**

- ▶ Long-term leases at below market rates (\$0.02/sq. ft.)
- ▶ 50% discount on Workers' Compensation Insurance
- ▶ No employee benefit packages required (medical, vacation, sick leave, etc.)
- ▶ State tax credits
- ▶ Reliable, motivated labor force
- ▶ Available locations throughout California
- ▶ Local production allows more control over supply chain and faster response times than producing offshore

**Businesses also enjoy:**

- ▶ A sense of pride in creating California jobs and transforming lives
- ▶ Ability to use the "Made in the USA" label
